ASSEMBLY

STEP 1a


ATTACH CAMERA TO MOUNTING **PLATFORM**

Cams w/ bottom attachment point


Rotate the camera screw clockwise while holding camera firmly. Line up the camera's lens with the triangular front pointer to center on the platform.

NOTE: Cameras are not included in the package.

Go to STEP 2

STEP 1b ATTACH UNIVERSAL CAMERA ATTACHMENT (UCA) ONTO CAMERA **MOUNTING PLATFORM**


Slide the UCA onto the camera mounting platform from the back. Line up the camera screw & rotate clockwise while holding the UCA firmly.

Ensure the ball "T" screw is tight but adjustable.

Go to STEP 1C or 1D

STEP 1c ATTACH CAMERA TO UCA

Cams w/ attachment point


Secure camera flat in contact with the top of the camera mounting platform & against the long flat side of UCA.

Attach the UCA screw through the slot on the ribbed side turning clockwise into the camera's threaded screw hole. Before final tightening ensure the camera lens is lined up with the triangular front pointer on the center of the camera platform.

STEP 1d

ATTACH CAMERA TO UCA

Cams w/no attachment point

Secure camera flat in contact with the top of the camera mounting platform & against the long flat side of UCA.


Using bungee cords secure through mounting devices on rear of your camera. Ensure bungees are firm, avoid wrapping around the front of camera to avoid blocking the lens & line up camera lens with the triangular front point on the center of the camera platform. This may take some experimenting to fasten securely, however, most quality cameras are equipped with the bottom or rear threaded receptacle.

INSTALLATION

STEP 2 CONNECT TREE ATTACHMENT TO EXTENSION POLE

Line up tree attachment with extension pole & make sure it snap/locks onto the pole into either hole.





STEP 3 MOUNT TREE ATTACHMENT

Connect necessary poles & select location. For best results tree attachment should be installed at approximately a 45° degree angle. Rotating the pole(s) clockwise, twist poles to desired depth. (at least half-way into the tree or until firm, depending on bark and tree thickness).

Drill Driver (included) allows you to use a cordless drill to rapidly screw in your tree attachments. Insert the driver into your drill and place into bottom of extension pole to spin the pole, attaching tree attachment to tree. For best results, use clutch-type cordless drill set at approx. 12-14.




STEP 4 CONNECT EXTENSION POLE TO CAMERA & CAMERA MOUNTING PLATFORM

Ensure the black "T" screw on the ball swivel is tight but will allow adjustment.

Snap extension pole to camera on the marked "INSTALL" side. The "REMOVE" side must only be used during camera removal from the site.

Position camera adjustment parallel to extension pole as shown by the arrow on the right.





STEP 5 INSTALL CAMERA MOUNTING PLATFORM & CAMERA TO TREE ATTACHMENT

Note: Be sure to turn camera settings on before installing.

Extend pole(s) to desired height.

Line up & snap camera mounting platform onto the tree attachment.

Pull the extension pole(s) straight back towards you to ensure a smooth release.



STEP 6 ATTACH & AIM LASER

Install 2 AAA Batteries (not included)

Laser can be susceptible to cold or heat. Laser can be warmed by holding diode (light) in hand for approx. 1 min. Very seldom are batteries the issue.

Tip: Keep in pocket or use handwarmers.

Insert laser by sliding into laser bracket. Rotating the laser counterclockwise (toward the pole) will activate the push button.





STEP 7 ADJUST CAMERA

With green laser turned on, insert extension pole to adjustment port & adjust/aim laser to location you want photos to be taken. NOTE: Laser needs to be in alignment with the green Locking Latch on the pole, as shown.





STEP8 CAMERA RETRIEVAL & REMOVAL

Line extension pole up with the green Locking Latch rotated to the Left and gently push/twist until it snaps into the "REMOVE" position. You will hear it click into the camera platform. Pull straight backwards and the camera platform will release.



STEP9 SAWBLADE

DO NOT REMOVE SAW SHEATH WHILE HANDLING/INSTALLING AND REMOVING THE SAWBLADE.

Attach saw blade by snapping onto the extension pole.

Remove any branches that are obstructing camera lens & view.

WARNING BLADE IS VERY SHARP USE CAUTION

TIP: Wear gloves while handling sawblade.

Replace protective sheath before removing sawblade.

Remove sawblade by depressing extension pole release lever & carefully pulling sawblade off.

Introduction

What is Covered
